Stockholm, Sweden, August 19 – 21, 2009

The year 2009 is full of challenges for the European river basin district authorities. For the first time, all EU countries will present River Basin Management Plans and Programmes of Measures for their river basin districts. The plans shall be decided no later than 22 December 2009. The Swedish River Basin District Authorities are delighted to invite our European colleagues to a meeting in order to exchange ideas and discuss our future challenges.

We see the meeting as an opportunity to reflect on, and learn from mutual experience, but also to look to the future and see how we can best meet the challenges that we are facing. This meeting is coorganised with the International Network of Basin Organizations, EUREAU and the Swedish Water and Wastewater Association.

A large part of the programme will be taken up by group discussions giving everybody a possibility to share their experiences with others. We believe in building networks between authorities – we have a lot to learn from each other. This is an agency meeting during the Swedish Presidency of the EU. Climate change and marine environment in particular will be at the top of the agenda for the Swedish Presidency. The Water Framework Directive has a strong connection to both these issues.

Also significant is that our meeting takes place during the annual World Water Week in Stockholm, the primary meeting point for global water issues. Part of our programme – in the afternoon of 19 August – is included in the World Water Week programme and as such is open to the general public. Days two and three, 20 – 21 August, are intended for River Basin District Authorities. We hope that many of the participants will also take the opportunity to be a part of the entire World Water Week, 16 – 22 August.


